The Phoenix Algorithm



STRATEGY DESCRIPTION

The Phoenix Algorithm trades the S&P Emini and Ten Year Note utilizing a proprietary blend of technical indicators designed to generate alpha while attempting to reduce risk. This algorithm is primarily a trend following/momentum based algorithm, while also taking on characteristics of a mean reversion algo. This system trades three distinct algorithms, including a Short Term ES, Day Trade ES and Intermediate Term TY algorithm.

These three algorithms were compiled into the Phoenix algorithm in February 2021 and began live in March 2021. All data posted is from the Back-Tested/Hypothetical Account unless otherwise noted and therefore carefully consider CFTC Rule 4.41 (below) prior to making any investement decisions.




