

**SYSTEM OVERVIEW**

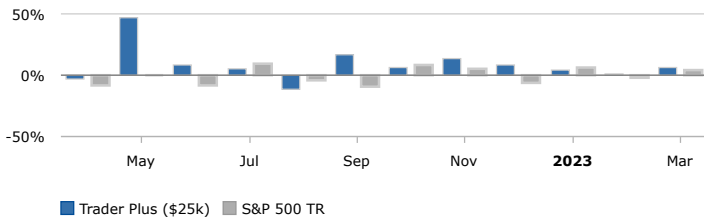
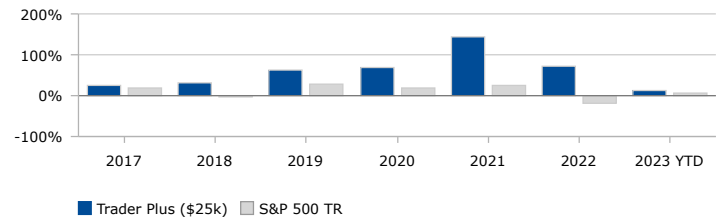
The Trader Plus trading system places long and short day trades on the S&P Emini futures. This is accomplished by using a proprietary blend of technical indicators designed to generate profits while greatly reducing risk. Trader Plus utilizes a total of three different trading strategies: Day Trade Long (v2), Emerald Long and Emerald Short. This trading system can place up to two day trades each day, and will exit all trades before 4PM EST. Results posted between January 2017 - March 2023 are Hypothetical/Back-Tested and subject to CFTC Rule 4.41 (below). The monthly performance data does not include the fees that we charge for the use of the algorithms.
